Law Reform Miscellaneous Provisions (Scotland) Act 1990 (Section 66 and Schedule 7) - subsumes the UNCITRAL Model Law on international commercial arbitration into the law of Scotland. Sections 89, 90 and 91 of the Arbitration Act 1996 (which extend the Unfair Terms in Consumer Contracts Regulations 1994 to arbitration agreements) also apply to Scotland.
